Assignment of space will be on a first-come, first-served basis based on when application is received. There will be no fee for the booth space. Set up will begin at 8am each market under the trees near the parking lot at Houmas House Plantation.

River Region Art Association Advisory Board will determine the location of all booths. Vendors will operate in a professional manner. Vendors will keep their

booths clean, sanitary and will make sure to leave the area spotless at the end of the day.

All booths must be family friendly. The River Region Art Association Advisory Board has the final say on all booth content and what may or may not be displayed or sold during the Market.

You must supply your own table, chairs, set up and tent, if desired. You must provide your own change for sales at your booth. You must take care of any taxes on your own... information will be provided. Should any booth have a credit card sale, it may be processed through the Gallery if they desire. The person making the purchase would come to a RRAA table set up for processing the credit card purchase. RRAA will take a 20% donation for processing any such sales. Payment to the vendor on such sales would be at the first of the month.
