1. In order to exhibit in the River Region Art Gallery you must first be a member of River Region Art Association. Types of Memberships:

- _____ **Member \$40 (July to December membership is pro-rated \$20)**
_____ **Family member---Spouse, child (one household) \$20 (pro-rated \$10)**
_____ **Youth \$20 (pro-rated \$10)**
_____ Supporter of the Arts \$40 (Donation/Inactive Member)

- Members are required to pay annual dues (due January 1 pay by January 31 of each year). Quarterly exhibit fees are due every quarter (4 times a year); fees should be received within 30 days after each quarter. After this time period Artwork can be removed if not paid: **Be sure to receive your copy of the Membership Packet.** Exhibit fees are explained in the "Quarterly Show Exhibit Guidelines". When calculating exhibit fees, measure the outside height and width of your art and multiply by 1 cent. Place all this information on the Exhibit Activity Record Sheet (Ear Sheet).
- Members are responsible for their artwork and must have display card on each item with appropriate information. (Artist name and number, inventory number, medium, sale price) Display cards are available at the Gallery. Attach display card in an appropriate and visible place; front bottom right hand corner. Each member is responsible for completing the Exhibit Activity Record sheet and placing it in the EAR Book. This is the member's way of keeping track of your sales and personal inventory at RRAA.
- Art must be submitted in a professional manner, ready for display; framed work must have screw eyes with wire only. **No saw tooth hangers accepted.** Artwork with no frame must have gallery wrap finish look.
- According to our bylaws Article IV, Section 12; RRAA is open to all art forms and all mediums. Art should be artist's original creation. Prints and/or reproductions are accepted. (Must be clearly indicated) If art is copied, the artist must obtain copyright privileges, and acknowledges the originator.
- A 20% donation is made to RRAA on any sales. Your check from any sales will be sent to you on the first of the following month. RRAA will take all possible care to protect your artwork. RRAA is not liability for damaged or loss artwork. RRAA has no insurance on contents of the Gallery.
- The Gallery Display Committee will re-evaluate displays at the end of each quarter and rearrange displays for marketing purposes to keep the gallery looking fresh.

I understand that RRAA is a non-profit, volunteer organization. I agree to do my part as a member; pay all dues and fees in a timely manner. I will volunteer one day a month at the Gallery or volunteer to help on a committee.
